Re: Including Vulnerable Afghan Religious Minorities in P-2 Refugee Program

Dear President Biden and Secretary Blinken:

We are an informal participant-led, multi-religious group that advocates for international religious freedom. Despite our extremely broad diversity of theological views and political positions, we are united in our horror at the unfolding events in Afghanistan following the U.S. troop withdrawal and Taliban takeover. We are especially concerned about the fate of vulnerable religious minorities in Afghanistan, who face abuses at the hands of the Taliban and its affiliates solely because of their religious beliefs. We are writing to urge the White House and the State Department to create an additional P-2 refugee status category for these Afghan religious minorities or to support Congressional efforts to enlarge the P-2 category on an emergency basis.

We collectively have assembled numerous reports of horrific mistreatment of religious minorities by Taliban militants and terror groups such as ISIS-K now roaming freely throughout Afghanistan. Christians, Shias (Hazaras and Nizari Ismailis), and other religious minorities have been murdered, whipped, tortured, had their ID documents seized, and their cell phones destroyed. They are being identified via government records and hunted down in door-to-door searches.[1] They are receiving officially stamped "threat letters" warning that they have been identified for arrest or worse. Property is being stolen. Women (and young boys and girls) are being seized, raped ("married" in the eyes of Taliban thugs), trafficked as sex slaves, or killed, and men are being summarily executed or tortured.[2]

In short, for many religious minorities their status as believers in a faith not approved by the Taliban is a death sentence. Reports of killings of religious minorities are increasing, and many are in hiding. Hundreds of Shia worshippers were killed or wounded in successive ISIS-K suicide bombings at mosques in Kunduz and in Kandahar on October 2 and October 15, 2021.[3] The United States must act to protect these communities now.

Unfortunately, religious minorities were not included when the State Department <u>created</u> a P-2 category for certain Afghan nationals who are at risk of harm on August 2, 2021.[4] Eligibility for a P-2 visa allows individuals who are members of a group that the U.S. government has identified as "of special humanitarian concern" to apply directly to the US refugee admission program (USRAP), without first having to obtain a US Embassy or NGO referral or having to apply, be processed, and be referred by the UNHCR.[5]

Removing these referral steps speeds up the process for P-2 refugees, although they still must undergo U.S. government processing and extensive security vetting. Thus, every USRAP applicant must meet the legal standard for refugee status—a well-founded fear of persecution based on religion, race, nationality, political opinion or membership in a particular social group—and show that they are otherwise eligible for admission under U.S immigration law.

Our request is supported by the U.S. Commission on International Religious Freedom recommendation that the U.S. State Department create a Priority 2 (P-2) category for vulnerable Afghan religious minorities. Similarly, Representative Jackie Speier (D-CA-14) introduced H.R. 4736 on July 28, 2021, with 45 co-sponsors, which would require the State Department to provide for priority refugee slots for Afghans at special risk of persecution, including those at risk due to their religion, race or nationality.[6] Other groups, including those representing humanists and atheists, have asked for P-2 visas for Afghan religious minorities.[7]

In light of rapidly deteriorating conditions for religious minorities in Afghanistan due to Taliban and ISIS-K ascendancy in the region, we recommended the following:

- 1) The U.S. State Department should create a new P-2 category for vulnerable religious minorities from Afghanistan. They should have direct access to USRAP. Their processing can take place at an intermediary (hub or lily pad) country (e.g., Qatar, UAE, etc.) since processing within Afghanistan is not presently possible. It is recommended that an initial annual group of at least 4,000 applicants (primaries and dependents) be included in the proposed expanded P-2 program, as follows (to be reviewed and assessed annually): Hazaras or other Shia: 1500; Christians: 1500; Ahmadis: 500; Sikhs: 250; Hindus: 250.
- 2) U.S. Congress should consider passing legislation creating a legal presumption of eligibility for refugee status for vulnerable religious minorities from Afghanistan, which would create a more

lenient reduced evidentiary burden than for other refugee applicants. This legislation can track the 1989 Lautenberg Amendment.

As precedent, the U.S. State Department, through supporting Congressional legislation, has granted P-2 status in the past to other religiously persecuted groups:

- o The 1989 Lautenberg Amendment extended P-2 status to certain Soviet religious minorities.
- o The 2004 Specter Amendment extended P-2 status to Iranian religious minorities.
- o A 2007 Kennedy-sponsored bill extended P-2 status to certain Iraqi religious minorities.

The situation in Afghanistan demands immediate steps that can save the lives of religious minorities in Afghanistan who face imminent harm. Thank you in advance for your attention to our requests, and we stand ready to meet with Administration officials and members of Congress to facilitate this effort.
